The attention of Sri / Smt / Kum. bearing Reg.No. is drawn to Para.5 (2) of Commission's Notification No.32/2007 which stipulated that the candidates who were qualified for Interviews but who could not get selection for the executive posts will be considered for Non-Executive posts. However such candidates were not asked to produce the memo of marks at the time of Interviews which are now required for considering for Non-Executive posts. Further in the Commission's memo 2nd cited 1088 additional candidates who were not called for interview were directed to produce certain certified copies as detailed therein in the memo along with filled in Check list & Photographs on or before 17-08-2009 for considering them for Non-Executive posts.

In continuation of the Memo 1st & 2nd referred above, the Commission now directs these two categories of candidates to produce the following certified copies of certificates to decide their suitability & eligibility for the Non-Executive posts of Group-II Services, Notification.No.32/2007.

- a) Memo of marks / consolidated memo of marks of Basic Degree or its equivalent along with Degree certificates.
- b) Memo of marks of P.G. courses or its equivalent along P.G. Degree certificate.
- c) Provisional / Pass certificate of Post Graduate diploma in Computers / Computer Science obtained after degree if any
- d) "A Level Course", "B Level Course", "C Level Course" of the DOEACC Society, if any

The candidate should note that they must have acquired (possessed) the qualifications claimed by them as on the date of Notification i.e. 28-12-2007. Candidates should enclose Xerox copy of this memo and Xerox copy of Hall Ticket along with the above certificates.

He / She is directed to note that the recruitment process is time bound and hence the required copies of certificates should reach the Commission's Office to the following address **on or before 25-01-2010 duly superscribing this memo no. and hall ticket no. on the envelop BY POST OR HAND DELIVERY.**
